## 1 OVERVIEW

On August 18, 2021, ENWIN Utilities Ltd. (ENWIN Utilities) filed an Incentive Rate-Setting Mechanism application seeking Ontario Energy Board (OEB) approval for:

- Distribution rates, retail transmission rates and other charges effective from January 1, 2022, including the disposition of amounts accumulated in certain deferral and variance accounts, and
- An amendment to the description for its Large Use – 3TS Service rate classification to remove the 5,000 kW demand threshold.

The OEB decided to hear ENWIN Utilities' Incentive Rate-Setting Mechanism application for 2022 rates in two phases. In Phase 1, distribution rates, retail transmission rates and other charges effective from January 1, 2022, and the disposition of amounts accumulated in certain deferral and variance accounts were approved by the OEB on a final basis on December 9, 2021.

In Phase 2, ENWIN Utilities' amendment to the description of the Large Use – 3TS Service rate classification was approved by the OEB on February 3, 2022. The OEB ordered ENWIN Utilities to file a revised Tariff of Rates and Charges with the new Large Use – 3TS Service rate classification description and any proposed labelling for this rate classification. ENWIN Utilities filed a revised Tariff of Rates and Charges with the OEB on February 9, 2022.

The OEB has reviewed ENWIN Utilities' revised Tariff of Rates and Charges and approves it as filed.

## 2 PHASE 2 PROCESS

In its Cost of Service application for 2020 rates<sup>1</sup>, ENWIN Utilities proposed that the former Large Use – Ford Annex customer classification be consolidated into the Large Use – 3TS Service customer classification. The consolidation proposal from the 2020 Cost of Service application was premised on creating one customer classification for ENWIN Utilities' customers that are serviced by dedicated ENWIN Utilities-owned and operated transmission-connected transformer stations.

In that proceeding, intervenors that were parties to a partial Settlement Agreement agreed to the proposed customer classification consolidation. The Settlement Proposal was approved by the OEB and incorporated in ENWIN Utilities' Tariff of Rates and Charges effective January 1, 2020.<sup>2</sup> To facilitate the consolidation of the Large Use – Ford Annex customer classification into the Large Use – 3TS Service customer classification, no adjustments to the Large Use – 3TS Service classification description were proposed or required, as both the existing customers and the new customer being classified in the consolidated rate classification satisfied the existing description.

All intervenors from ENWIN Utilities' 2020 rates Cost of Service application were approved as intervenors in Phase 2 of this proceeding. These parties were:

- Association of Major Power Consumers of Ontario (AMPCO),
- Consumers Council of Canada (CCC),
- School Energy Coalition (SEC), and
- Vulnerable Energy Consumers Coalition (VECC).

Customers in ENWIN Utilities' Large Use – Regular and Large Use – 3TS Service rate classifications were invited to seek intervenor status in Phase 2 of this proceeding; however, none chose to intervene.

On January 13, 2022, the OEB held a Technical Conference where AMPCO, SEC, VECC and OEB staff asked questions regarding the evidence filed in this proceeding.

AMPCO filed its written submission with the OEB on January 26, 2022. SEC, VECC and OEB staff filed their written submissions with the OEB on January 27, 2022.

ENWIN Utilities filed its written reply submission with the OEB on January 31, 2022.

The OEB issued its Decision and Order for Phase 2 of this proceeding on February 3, 2022. In its Decision and Order, the OEB ordered ENWIN Utilities to file a revised Tariff of Rates and Charges with the new Large Use – 3TS Service rate classification description and any proposed re-labelling for this rate classification.

ENWIN Utilities filed a revised Tariff of Rates and Charges with the OEB on February 9, 2022.

### 3 DECISION

On February 9, 2022, ENWIN Utilities filed a revised Tariff of Rates and Charges with the OEB, reflective of the Decision and Order issued by the OEB on February 3, 2022. In this revised Tariff of Rates and Charges, ENWIN Utilities proposed to re-label the Large Use – 3TS Service rate classification as the Dedicated Transformer Station Service rate classification.

ENWIN Utilities noted that the revised label addresses the suggestions noted in the OEB's Phase 2 Decision and Order and is reasonably descriptive of the service provided to consumers in the rate classification. The revised rate classification description in ENWIN Utilities' revised Tariff of Rates and Charges is as follows:

**DEDICATED TRANSFORMER STATION SERVICE CLASSIFICATION**

This classification applies to a customer whose premises is serviced by a dedicated Transformer Station. Class A and Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

ENWIN Utilities also made an administrative update to the Wireline Pole Attachment charge on its revised Tariff of Rates and Charges to reflect the OEB's updated Wireline Pole Attachment charge.<sup>3</sup>

#### Findings

The OEB finds that ENWIN Utilities' revised Tariff of Rates and Charges is reflective of the OEB's February 9, 2022 Decision and Order. The OEB approves the Tariff of Rates and Charges as filed, effective January 1, 2022.

## RESIDENTIAL SERVICE CLASSIFICATION

A customer qualifies for residential rate classification if their service is a 120/240 V single-phase supply to a single family dwelling, duplex, triplex, 4-plex or 6-plex, townhome or multi-unit - individually metered apartment, located on a parcel of land zoned by the City of Windsor Building Department for domestic or household purposes and where the customer uses the dwelling as a home. Where a customer operates an advertised business from a building that may or may not be used as a dwelling, EnWin Utilities Ltd. may elect to deem that the customer's rate class will be General Service. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

## APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

## GENERAL SERVICE LESS THAN 50 KW SERVICE CLASSIFICATION

A non-residential customer qualifies for a rate classification of General Service Less Than 50 kW if within the last 12 months its monthly average peak demand load has not exceeded 50 kW or for a new customer is not expected to exceed 50 kW. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

### APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

## **GENERAL SERVICE 50 TO 4,999 KW SERVICE CLASSIFICATION**

A non-residential customer qualifies for a rate classification of General Service 50 to 4,999 kW if within the last 12 months its monthly average peak demand load has equaled or exceeded 50 kW or for a new customer is expected to equal or exceed 50 kW but be less than 5,000 kW. Class A and Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

### **APPLICATION**

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

**GROSS LOAD BILLING NOTE**

The Billing Demand for Line and Transformation Connection Services is defined as the Non-Coincident Peak demand (MW) in any hour of the month. The customer demand in any hour is the sum of (a) the loss adjusted demand supplied from the distribution system plus (b) the demand that is supplied by embedded generation installed after October 30, 1998, which have installed capacity of 2MW or more for renewable generation and 1 MW or higher for non-renewable generation. The term renewable generation refers to a facility that generates electricity from the following sources: wind, solar, Biomass, Bio-oil, Bio-gas, landfill gas, or water. The demand supplied by embedded generation will not be adjusted for loss.
